Robert Laminage SA operates according to the highest standards of the metals industry. Our commitments are based on quality, safety, environmental responsibility, ethics and transparency. We fully assume our role as a Swiss industrial company and work to preserve the trust of our customers and partners.

1. Corporate Social Responsibility (CSR)

Our CSR approach relies on three pillars:

Environment

- continuous reduction of our environmental impact,
- improvement of energy efficiency,
- rigorous sorting and recovery of metallic and industrial waste,
- increasing use of recycled materials.

Social

- strict respect for human rights,
- safe and healthy working conditions,
- fair and non-discriminatory treatment of employees.

Governance

- integrity in business practices,
- transparency,
- prevention of corruption and conflicts of interest.

Robert Laminage SA is a member of **APIAH** and applies the industry-wide **Occupational Health & Safety Solution** recognised by SUVA/CFST.



2. Regulatory Compliance

RLSA complies with all applicable regulations, including:

- **REACH (EC 1907/2006)**: no SVHC > 0.1% unless communicated under Article 33;
- **RoHS (2011/65/EU, 2015/863)** when applicable;
- **California Proposition 65** where relevant;
- **Minnesota Lead and Cadmium Law** depending on product destination.

All required documentation (SDS, regulatory declarations, material certificates, test reports) can be provided upon request.

Principle of transparency and reasonable limitation of liability

Robert Laminage SA is not in a position to audit the entire upstream value chain.

All regulatory information and declarations published by RLSA are based exclusively on the data, certificates and documents provided by our suppliers and partners.

Although we perform consistency checks and request up-to-date documentation, we cannot be held responsible for omissions, inaccuracies or non-compliance originating from third parties over whom we have no direct control.

3. Responsible Minerals & Metals

We implement due diligence in line with:

- **OECD Due Diligence Guidance (2016)**,
- **CMRT (3TG minerals)**,
- **EMRT (cobalt and mica)**,
- assessment of smelter status according to the **RMAP** programme.

Suppliers are required to ensure adequate transparency of their supply chain.

Smelters classified as *Non-Conformant* under RMAP are excluded from our supply chain.

In line with Section 2 above, RLSA relies on information communicated by its suppliers and cannot verify every level of the global supply chain.

4. Energy & Efficiency

- **100% renewable electricity** for all production activities,
- heating provided by **gas or fuel oil**, depending on operational needs,
- implementation of our **Energy Charter**, including a target of **-10% energy consumption by 2027**.



5. Raw Materials & Circular Economy

- **60–80% recycled content** depending on alloy,
- carbon footprint reductions of **–65% to –85%** when using recycled materials,
- full recyclability of copper-based alloys within certified industrial loops,
- rigorous waste management with certified recycling partners.

6. Health, Safety & Quality

We ensure:

- safe and legally compliant working conditions,
- strict internal safety procedures,
- high product quality supported by process controls and full traceability.
